The Full Season Entrant Fee is \$26,000 per car. This Includes:

- Reduced Entry Fee for all 2012 events
- Car Number for the Full Season and Right of First Refusal on the Number for the following Season
- One Single Event Credential per event
- Two Annual Parking Passes (no paddock access)
- One Full season Delivery Pass (for delivery access to paddock)

With exception of Montreal, all events will have two (2) – 45 minute races Montreal will have one (1) – 30 minute race

In order to qualify as discounted Full Season Entrant 50% payment (\$13,000) must be received prior to the close of business January 6th, 2012. Balance of Full Season payment (\$13,000) is due prior to close of business March 9th, 2012.

A Driver/Entrant or a Team with a Driver TBA may enter for the Full Season or a single event.

Other Information: After January 6, 2012 teams entered for the Full Season will have first priority on the entry list. All other entries will be accepted on a first- come, first -serve basis until the field is complete. A team will be entered for an event only after IMSA has received their entry form and fees for that event.
